Offer a flexible number of meetings at various times to meet the needs of parents.

Involve Rico parents of both sessions in the morning and evening group to become part of the planning, review, and improvements of the Parent Family Engagement programs. Also, including the Parent Family Engagement policy and development of the school wide program plan under section 1114 (b) if a program plan is yet not active.

Provide parents with timely information about Title I programs and school performance achievements levels of the state academic standards. As well as their child's academic folder in which projects their child's performance per six weeks. Recruit Lighthouse parent representative.

Provide parents with program/evaluations where they are given the opportunity to openly make suggestions, complaints or ask questions.

Emphasize the importance of communication between teachers and parents. Using technology resources (google meets, class dojo, remind 101, text, calls) in addition to what has been already in place as a requirement which is the on-going parent-teacher conferences in which the compact is presented in each meeting, progress-reports and opportunities to volunteer virtually participating in meetings, due to COVID-19 precautions no parent volunteers in person.
