IV. Discussion and Possible Action for the Board to Rank the Attorney Firms that Responded to the Request for Qualifications to Provide Legal Services to the District (RFQ #21-01-21)

During the December 17, 2020 Regular Board Meeting the Board approved the Administration to release a Request for Qualifications (RFQ) for attorney firms to provide legal services to the district. An advertisement was placed in The Monitor on December 23 (Wednesday) & 27 (Sunday), 2020. The Request for Qualifications was released on December 23, 2020 with a deadline of Wednesday, January 6, 2021.

The following criteria relating to experience was requested in the Request for Qualifications:

- 1. Licensed to Practice as Attorney(s) in the State of Texas
- 2. Have at least 5 years of experience in the field of School District Law (all areas).

<u>A total of three (3) Qualification Statements were received from the following attorney firms:</u> >O'Hanlon, Demerath & Castillo – Austin, Texas/Pharr, Texas

>Law Office of Eloy Sepulveda - Weslaco, Texas

>Walsh, Gallegos, Trevino, Russo & Kyle, PC – Austin, Texas/Harlingen, Texas

Dr. Canales provided the following information on the ranking process:

•A subsequent special called meeting will be scheduled for the Board to:

>Approve a contract with the attorney firm ranked #1. In the event that the Board is not able to negotiate a contract with the attorney firm ranked #1, negotiations will be terminated.

- >Then contract negotiations will be initiated with attorney firm ranked #2. In the event that the Board is not able to negotiate a contract with the attorney firm ranked #2, negotiations will be terminated.
- >Then contract negotiations will be initiated with attorney firm ranked #3. In the event that the Board is not able to negotiate a contract with the attorney firm ranked #3, negotiations will be terminated.

>The procurement process will start all over again.

Each board member received a summary of qualifications of each firm and a ranking sheet. One board member attended the meeting virtually and received a ranking form as well.

The board members took a few minutes to rank the firms from #1 to #3 with #1 being the top selection. The attorney firm with the lowest overall score was considered the highest ranked firm.

## The results of the ranking were as follows:

- 1. Walsh, Gallegos, Trevino, Russo & Kyle, PC Austin, Texas/Harlingen, Texas
- 2. Law Office of Eloy Sepulveda Weslaco, Texas
- 3. O'Hanlon, Demerath & Castillo Austin, Texas/Pharr, Texas

Andrew Gonzalez made the motion to approve the results of the ranking as presented. Dr. Jaime Rodriguez seconded the motion and it passed unanimously.
