Apr 22- May 2*	Algebra I
Make Ups by May 2 (Fri.)	<i>Make-up sessions for tests scheduled to be administered on Apr 22-May 2, 2025, must be completed by the end of this day.</i>
June “Online” Test Dates	2025 STAAR End of Course
Jun 17-Jun 27 *^	Algebra I    English I    English II    Biology    US History
Make Ups by Jun 27 (Fri.)	<i>Make-up sessions for tests scheduled to be administered on Jun 17-27, 2025, must be completed by the end of this day.</i>

^ If a district is no longer in session (i.e., providing instruction to students) during the June administration window, the district may adjust the testing schedule to test on Monday, June 16, 2025.

\*Districts may choose to administer assessments on Monday of the second testing week without submitting a request to TEA.
